

Argyle Community Scholarship Award

General Information

1. Any graduating senior who plans to continue his/her education beyond high school is eligible for an award.
2. The scholarship will be given in two equal installments at the beginning of the first and second semester. To obtain the first half of the scholarship, the recipient must present a bill or statement to the treasurer of the Scholarship committee. If at any time he/she ceases attending college, he/she will forfeit his/her scholarship. The committee treasurer may request a full or partial refund.
3. If the student is a recipient of the Community Scholarship, they must apply for scholarship money within the first two years after receiving the award. It will be forfeited after two years.
4. Students who have received full financial aid from a college should bear in mind that NEED as well as academic standing plays a large role in the selection of candidates.
5. Your application and all of your components shall be regarded as CONFIDENTIAL.
6. Award will be announced at graduation.
